This agreement is entered into as of (date) _____ between the undersigned (“Customer”) and Green Oil Incorporated (“Agent”). The parties agree as follows:

- Services:**
 - Used Cooking Oil Collection:** Customer grants Agent the exclusive right to collect, transport, and process all of Customer’s used cooking oil (UCO) from the locations set forth below and Agent agrees to act in accordance with the terms and conditions of this agreement.
 - Grease Trap Cleaning:** Only applies to the customer who wants GOI to clean Grease Trap. Unless special agreement is made between Customer and Agent, the basic rate according to the trap size is as follow; \$ (_____) + HST for _____ (size of grease trap) and clean once/ _____ weeks or months(circle)
- Terms of Agreement:** Agent will provide and install suitable containers for UCO of charge with no deposit required. Agent will pay for the collected UCO to Customer the following amount: Price to be paid per litre: \$ _____. Risk and title to the used oil passes from the customer to GOI, once Agent pumps the oil out to GOI tank truck.
- Waste Materials:** Customer warrants that UCO collected by Agent will not contain material such as water and/or garbage, grease, sludge, waste food, animal fat (especially goat and sheep), shortening and/or radioactive, flammable, explosive, toxic, or hazardous material.
- Self-Declaration:** By signing this agreement, the self-declaration (as well as the terms and conditions) as published on the website (www.greenoilinc.com) apply and are a valid part of this agreement for the contractual period. If no objection is made by the customer 14 days before the expiry of each calendar year of this agreement, the self-declaration is confirmed for the following year.
- Term:** This agreement is for an initial term of two years commencing on the date above and will automatically renew for successive one-year periods unless either party gives written notice to the other to terminate the Agreement effective at the end of the then-current period. Provided containers shall be removed from the Customer’s property within 30 days after written notice is given.
- Termination:** So long as customer honors the exclusive arrangement referred to above and performs its obligations regarding waste materials under this Agreement, Customer will not be charged for the Service. If Customer breaches its obligation hereunder, Agent reserves the right to terminate this Agreement or charge the Customer for the service at the prevailing rates in the collection industry.
